1. Project and partnership Development

By attending various conference, workshops, and events related to a broad range of topics, I developed a much more mature understanding about youth, entrepreneurship, business and human rights. When exchanging ideas with other participants and trying to look for cooperative opportunities, I felt that I found a group of people who are genuine and sincere in advocating development.
